#### A. Universal and correct wearing of masks

The universal and correct wearing of masks is optional for all students/staff and visitors in all buildings, buses, etc.

#### B. Physical distancing (e.g., including use of cohorts/podding)

Physical distancing for students/staff and visitors has been significantly relaxed and will be implemented/accommodated on an as needed basis.

#### C. Handwashing and respiratory etiquette :

Handwashing and respiratory etiquette practices remain in place. Signage, hard sanitizer and portable hand sanitizing stations appear thought our buildings. Students and staff are encouraged to wash hands and cover their coughs etc.

### D. Cleaning and maintaining healthy facilities, including improving ventilation.

Cleaning and maintaining healthy facilities remains in place via the cleaning and disinfecting schedules. This includes routine clearing and disinfection of surfaces and objects that are frequently touched, sanitizing bathrooms, and nurses offices. All HVAC units are now equipped with bipolar ionization units and will continue to be cleaned and maintained along with scheduled filter replacements throughout the year.

# E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal Health Departments

It is recommended that individuals (staff and students) who test positive for COVID-19 should be isolated for five (5) days. Symptoms must be improved, and individuals must remain fever free for 24 hours (without fever reducing medication) prior to returning to school. Household members of an individual who test positive do not need to quarantine. Students and staff who have symptoms of illness (fever, heavy cough, nausea, etc.), should stay home from school and consult with their healthcare provider as needed.

#### F. Diagnostic and screening testing

Diagnostic and screening testing is not required. Individuals may contact their healthcare provider on an as needed basis.

#### G. Efforts to provide vaccinations to educators, other staff, and students, if eligible

The district does not provide vaccinations to educators, staff and students. Individuals may contact their health care provider for these resources on an as needed basis.

#### H. Appropriate accommodations for children with disabilities with respect to the health and safety policies

Appropriate accommodations for children with disabilities with respect to health and safety policies will be addressed on a case by case basis by the child study team and school nurses.

The district will be returning to pre-COVID procedures for student absences and will no longer provide remote/virtual instruction for COVID related absences. Assignments will be provided via Google Classroom and/or teacher provided materials. A multi-tiered system of support and wrap-around services have been established to ensure that students receive academic and counseling support throughout the year. The technology department has an established screening process to identify connectivity needs for students. Students identified as eligible for free and reduced meals are offered daily lunch at each school.

The plan was reviewed and discussed within the Hanover Township Board of Education Committees and with the Hanover Township Education Association. It was presented at PTA Advisory Council and follows the guidance communicated via the September 2022 opening of schools letter sent to all parents. It was included as an agenda item at the December 13th Board of Education meeting, at which time the public was invited to comment.
